If the contractor L1 does not submit Demand Draft / FDR / Bank Guarantee of additional security deposit (if applicable) within 8 days from the date of financial opening at the office of Civil Surgeon, IDW, NHM, DDHS, Latur then his earnest money deposit will be forfeited and his tender will not be considered for acceptance, then offer will be treated as "Non Responsive".
